- Assisted the Chairman in all negotiations with the Budget Committee Chairman in how the budget resolution and the reconciliation instructions would affect programs within the jurisdiction of the Committee.
- Was the lead House staffer in responding to the Gramm-Rudman-Hollings legislation that was attached to the public debt limit increase. Coordinated staff from the five Committees involved in the conference Committee. Helped write the language that ensured there was no flexibility given to the Administration in how the reconciliation instruction affected each program.
- With the assistance of the Congressional Budget Office, developed the table that combined spending and revenue provisions and showed how each iteration of the 1990 budget agreement affected families across the income distribution. Was the first time spending and revenues had been merged in distribution tables. Was also unique in how families of different sizes were compiled. As a result of that work, I was profiled in the NYT.
- With the assistance of CRS, Agency staff and CBO, compiled 13 editions of the Green Book – a compendium of information regarding each program within the jurisdiction of the Committee. Each program was described, how they were administered and financed, eligibility for the program, who was served, number of participants, recent legislative changes and how the program affected well-being.
- As Subcommittee staff director, developed the legislation on Family Preservation. Also during the 1990 recession, wrote several versions expanding the Unemployment Insurance Program.
